Dear Secretary Deixler:

The Brooklyn Union Gas Company d/b/a KeySpan Energy Delivery New York and KeySpan Gas East Corporation d/b/a KeySpan Energy Delivery Long Island (together, the "KeySpan Energy Delivery Companies" or the "Companies"), hereby file three (3) copies of their revised Gas Transportation Operating Procedures Manual. The Manual has been revised to (a) incorporate changes required by the Commission's August 28, 2000 "Order Revising Pipeline Capacity Requirements for Marketers" (the "August 28th Order") in the above-captioned proceeding; (b) include certain revisions suggested by Staff; and (c) reflect recently filed amendments to the Companies' tariffs.

In further compliance with the August 28th Order which approved the Companies' 2000-2001 winter capacity program and directed elimination of the winter standby capacity option (see pages 1, 4, 8 and 14), the KeySpan Energy Delivery Companies are filing electronically, on October 13, 2000, amendments to the following tariff leaves, to become effective on November 12, 2000:
