The Company is filing the above tariff leaves as a housekeeping filing to correct minor errors contained on the above listed tariff leaves.

Leaf No. 23 has been revised in order to delete Rule 2.3.2 which required that the Company issued an "approved valid energy permit" prior to the attachment of commercial and industrial customers. This sentence is being deleted in order to conform to Company practices which have been in place for several years.

Leaf No. 24 has been modified in order to renumber the paragraphs resulting from the change on Leaf No. 23.

Leaf No. 34 has been revised in order to change the words "Commodity Cost Adjustment Clause in accordance with Rule 17.13" to "Monthly Cost of Gas in accordance with Rule 17.3." This is a correction to the cost of gas reference which was inadvertently missed in the Company*s filing which became effective November 1, 1999 in Case Nos. 99-G-0170, 99-G-0591, and 99-G-0336. Leaf No. 126 has been modified to delete the reference to the base cost of gas in the definition of Margin (M) used in the calculation of the Weather Normalization Clause. This change should also have been included in the Company*s November 1, 1999 filing reference above.

Leaf No. 164 has been modified to reference the Daily Contract Demand Rate to the rate as stated each month on the Gas Transportation Rate Statement. This change is consistent with the end of the Company*s rate case on October 31, 1999 and should also have been included in the Company*s November 1, 1999 filing.

Leaf No. 166 has been modified solely to revise the reference to Special Provision L to Special Provision K.

Leaf No. 185 has been revised to eliminate the reference to Aggregators consistent with the Company*s Uniform Business Rules filing made on April 26, 1999 in Case No. 98-M-1343.

Leaf No. 197 has been revised to eliminate the sentence which indicates that the balancing rate will remain in effect through October 31, 1999. This balancing rate continues to be in effect and is currently set forth on a statement which has been filed with the Public Service Commission.

Leaf No. 197.27 has been modified in order to change the word "an" in Paragraph 3 to "and".

The Company requests waiver of newspaper publication of the proposed changes required by 16 NYCRR 720-8.1 as the changes filed herein have no significant impact on the Company*s customers.
