The purpose of this tariff filing is to comply with the Commission's June 17, 1999 "Comprehensive Order Approving Transfers of Generating Facilities and Making Other Findings" in Case 96-E-0897 - In the Matter of Consolidated Edison Company of New York, Inc.'s Plans for (1) Electric Rate/Restructuring Pursuant to Opinion No. 96-12; and (2) the Formation of a Holding Company Pursuant to PSC Section 70, 108, and 110, and Certain Related Transactions. JOINT PETITIONS FOR APPROVAL OF GENERATION ASSET TRANSFERS. That order explains that "KeySpan has committed, on behalf of its LDC affiliates, to implement nondiscriminatory standards for interconnections with other electric generators and to submit to pre-established dispute resolution procedures to resolve disputes with new entrants," and "KeySpan reports that its LDC affiliates will file this proposal within 30 days after issuance of this Order as either amendments to their tariffs or as part of any gas operating procedures referenced therein."
