Attached for filing electronically with the Commission are the following tariff leaves, issued by KeySpan Gas East Corporation d/b/a KeySpan Energy Delivery Long Island ("the Company"), to become effective on January 9, 2002:

The Company is filing these leaves to establish a new category of its Interruptible Sales and Transportation Service provided under Service Classifications 4 and 7. The new category will be known as Distribution System Restricted Service (DSRS). DSRS is a lesser level of service than the other four categories of service currently included in these service classifications. It will be

to customers located in the most operationally constrained portions on the Company's distribution system where the Company is unable to provide a higher level of service. The DSRS category of service will be the first category of service to be interrupted in those service classifications during periods of interruption.

The DSRS category of service is necessary to address the concerns raised in this proceeding in the complaint by the Nassau-Suffolk Hospital Council, Inc. regarding interruptions of gas service by the Company during the 1999-2000 winter. In its Order Establishing Interruptible Service Guidelines for KeySpan Energy Delivery Long Island, mimeo at 6 (January 31, 2001), the Commission addressed that complaint and ordered the Company to "interrupt only the amount of load needed to insure system reliability. To the extent that the company implements a partial interruption, it should interrupt first according to operational constraints on the system."

The Company's system contains areas of operational constraint that in the past have caused it to interrupt all customers in these service classifications, whether or not they resided in the constrained areas, in order to maintain service to its firm service customers. Establishment of the DSRS category of interruptible service and clarifying that customers in that category will be the first to be interrupted will allow the Company the flexibility to maintain interruptible service to the other categories of customers in these service classifications during periods when, under the existing tariff provisions, they would have been interrupted with the entire service class. Establishment of the DSRS category of interruptible service also complies with the Commission's January 31 Order and provides clarity and certainty to those affected customers.

To ensure that the affected customers receive notice of this filing, the Company is serving it on the attached list of parties.

Due to the importance of this issue and the urgency of the impending commencement of the winter heating season, the Company requests that the Commission act on this filing on an emergency basis pursuant to Section 202(6) of the State Administrative Procedure Act (SAPA). Immediate adoption of this filing is required to preserve the general welfare. Interruptible service is crucial to the Company's ability to manage its system in a safe and reliable manner. Adoption of the DSRS category of interruptible service is critical to the continued economic well being of onsystem interruptible customers, particularly during the heating season. Compliance with the advance notice and comment procedures of SAPA would postpone adoption of this filing until well into the winter, a period of time during which the Company could have interruptions on an "all or nothing" basis, and would therefore be contrary to the public interest.

In addition to the tariff changes implementing the DSRS category of service, the Company also submits housekeeping changes to Leaves 94 and 108 updating the SC 4 and SC 7 Forms of Service Agreement to include therein the penalty provisions contained in those service classifications. The Company inadvertently did not make these changes when it amended the service classifications and regrets any inconvenience to the Commission as a result.

To the extent the Commission deems it necessary, the Company also requests that the Commission approve the Secretary's acceptance of this filing pursuant to Section 61.10 of the Commission's Regulations. 16 NYCRR Section 61.10. Leaf 129.1 currently is under suspension and Section 61.10 states that under that circumstance, other tariff changes may not be accepted for filing without the Commission's approval. The Company submits that the instant filing falls within the exceptions to that rule enumerated in Section 61.10 (c) (1) and (c) (5), respectively, because this filing is "made pursuant to an applicable order of the commission" and reflects "changes in the terms and conditions of service, other than rates and charges, without substantial revenue or customer bill effects." However, should the Commission disagree, the Company requests that the Commission exercise its discretion and approve the acceptance of this filing.
