In addition, the Company hereby submits for filing Supplment No. 13 to its Schedule for Gas Service, P.S.C. No. 4 - GAS. Supplement No. 13 is issued September 29, 2000 to become effective on September 30, 2000.

On September 5, 2000 the Company filed revisions to Service Classification No. 3 ("SC 3") and Service Classification No. 8 ("SC 8") of its gas tariff in compliance with the Commission's August 24, 2000 Order Directing Utilities to File Revised Interruptible Gas Service Tariffs ("August 24th Order") in the above-referenced proceeding. After subsequent discussions with Commission Staff, the Company has agreed to modify its September 5, 2000 filing as follows.

- 1) Emergency Service provisions, which were proposed to be eliminated in the September 5, 2000 filing, shall remain in the Company's tariff at this time.
- 2) The Penalty Surcharge provisions of SC 3 and SC 8 have been further revised to permit the Company discretion in imposing the Penalty Surcharge.
- 3) The penalty previously proposed in the "Customer Responsibilities"

special provision has been deleted.

- 4) The special provision, "Reserve Requirements" has been revised to clarify that the requirements of the provision must be met on November 1 of each year.
- 5) The previously proposed three-day reserve requirement for new customers has been deleted.

The requirement of Section 66(12)(b) of the Public Service Law as to newspaper publication of these additional proposed tariff revisions is waived per the August 24th Order.
