The purpose of this filing is to set forth the Company's updated NYSEG Fixed Price (BRO) rates that become effective April 1, 2006.

The updated NYSEG Fixed Price (BRO) rates filed herein are the result of changes in the cost of fixed price service that have occurred since October 1, 2005. Customers who chose or were defaulted to the NYSEG Fixed Price (BRO) rate or the NYSEG Fixed Price with Supply Credit (BRO w/RAC) rate that became effective January 1, 2005, April 1, 2005, or October 1, 2005 and who remain on those rates, are not affected by the April 1, 2006 rate change filed herein.
