Dear Secretary Brillling:

The enclosed schedule, issued by Niagara Mohawk, d/b/a National Grid ("Company"), is being transmitted for filing in compliance with the requirements of the Public Service Commission ("PSC") of the State of New York.

Schedule PSC No. 220 Electricity

Effective: April 27, 2009

This new schedule supersedes the current electric schedule, PSC No. 207, and is being proposed solely to fulfill the requirements of the PSC's Electronic Tariff System (ETS) to have all utilities in New York State file their respective tariffs in electronic format. To fulfill this directive, it is necessary for the utilities to cancel their current schedule(s) and submit new ones formatted for the ETS system. With this filing, the Company complies with this directive and respectfully submits PSC No. 220 Electricity.

PSC No. 220 contains only one substantive change from the Company's current electric service tariff, PSC No. 207. That change is the addition of the following language on Original Leaf No. 1 of PSC No. 220:

*P.S.C. No. 220 Schedule for Electric Service* ("P.S.C. No. 220 Electricity Tariff") supersedes and replaces former *P.S.C. No. 207 Schedule for Electric Service* ("P.S.C. No. 207 Electricity Tariff") effective April 27, 2009 ("Effective Date"). As of the Effective Date, all references to P.S.C. No. 207 Electricity Tariff in agreements existing as of the Effective Date shall be construed as references to P.S.C. No. 220 Electricity Tariff.

The Rule Numbers, Forms, and Service Classifications in P.S.C. No. 220 Electricity Tariff as of the Effective Date are identical to those of P.S.C. No. 207 Electricity Tariff as of the day immediately prior to the Effective Date, but Leaf Numbers may differ. To avoid any possible ambiguity resulting from this change, references to Leaf Numbers in P.S.C. No. 207 Electricity Tariff in agreements existing as of the Effective Date shall be construed as references to the equivalent Leaf Numbers for the same Rule Numbers, Forms, and Service Classifications in P.S.C. No. 220 Electricity Tariff.

This language was added to make clear that any references to P.S.C. 207 or any of the leafs contained therein in any pre-existing contract or agreement shall be construed as referring to P.S.C. 220 Electricity or the corresponding leafs contained in P.S.C. 220 Electricity, as the case may be, and the rights and obligations of the parties remain the same. Additionally, certain minor housekeeping revisions have been made and the provisions of PSC No. 207 have been reformatted to meet the requirements of the ETS.

NIAGARA MOHAWK POWER

Because there will be no customer impacts with this filing, the Company requests waiver of the requirements of newspaper publication as required by 16 NYCRR Part 720.
