**Re: Case 07-M-0548, Energy Efficiency Portfolio Standard**

Dear Secretary Brillling:

Enclosed for filing with the New York State Public Service Commission (the "Commission") are revised schedule leaves issued by Consolidated Edison Company of New York, Inc. ("Company") applicable to its customers in the City of New York and the County of Westchester. This filing reflects revisions to the Company's Schedule for Gas Service, P.S.C. No. 9 –Gas (the "Gas Tariff")

The tariff leaves reflecting the proposed revisions are identified in the table below:

The leaves are issued July 31, 2008 to be effective on October 1, 2008.

**Reason for the Proposed Filing**

Pursuant to the Commission's Order Establishing Energy Efficiency Portfolio Standard and Approving Programs issued and effective June 23, 2008, in Case 07-M-0548, (the "Energy Efficiency Order") the Company has been directed to establish a gas System Benefits Charge ("SBC") and to collect incremental SBC amounts from October 1, 2008 through December 31, 2011. The Company is filing tariff amendments, herein, in accordance with the Energy Efficiency Order.

### **Summary of Proposed Changes**

The Company is making the following tariff changes in compliance with the Energy Efficiency Order:

- The leaves identified in the table above have been amended to include a reference to or explanation of a System Benefits Charge for gas, which will be based upon \$1,084,472 for the period October 1, 2008 to December 31, 2008 ("Initial Period"), and \$4,337,887 for each annual period beginning January 1, 2009, and ending December 31, 2011. A reconciliation of actual collections during the Initial Period will be conducted and included with the SBC effective January 1, 2009. Thereafter a reconciliation of each annual period's amount will be conducted and included in the subsequent year's SBC.
- Leaf 6 and leaf 255 have been amended to include a System Benefits Charge in the Table of Contents.

The Company is also making the following housekeeping changes:

- Leaf 6 is being amended to include in the Table of Contents a reference to the Curtailment Cost Recovery Surcharge, which had been omitted.
- Leaf 255 is being amended to include in the Table of Contents a reference to the Revenue Decoupling Mechanism Adjustment, which had been omitted.
- Leaf 303.2 is being amended to include an explanation of the Revenue Decoupling Mechanism Adjustment, which had been omitted from the Other Rates, Charges and Adjustments section of SC9.
- Leaf 349 is being amended to exclude a reference to the Revenue Decoupling Mechanism Adjustment, which is not applicable to SC13 customers.

Attached to this filing is a Statement of System Benefits Charge applicable to firm sales and firm transportation customers.

### **Conclusion**

Pursuant to Ordering Clause 6 of the Energy Efficiency Order, the Company is filing the tariff amendments on not less than 60 days' notice to become effective on October 1, 2008. Furthermore in accordance with Ordering Clause 6, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of the changes proposed by the tariff amendments are waived.
