Reasons for Proposed Revisions

This filing is being submitted in further compliance with the Commission's Order Establishing Energy Efficiency Portfolio Standard and Approving Programs, in Case 07-M-0548, issued and effective June 23, 2008 ("EEPS Order") and with the Commission's Order Regarding Retail Renewable Portfolio Standard ("RPS"), in Case 03-E-0188, issued and effective September 24, 2004 ("RPS Order") to consolidate revisions submitted in the aforementioned Cases. Tariff revisions were previously submitted, separately, for compliance with the EEPS Order and the RPS Order, both being effective October 1, 2008. On August 1, 2008, the Company filed revisions to its tariff in compliance with the EEPS Order to begin collecting additional revenue through the existing System Benefits Charge ("SBC") to fund Energy Efficiency programs. On September 15, 2008, NYSEG filed an update to its RPS rate in compliance with the RPS Order. Each of those filings made changes to the same tariff leaves. The proposed revisions herein reflect the consolidation of these filings to ensure that the rates that were filed in compliance with each Order become effective on October 1, 2008.

The Company has discussed these revisions with PSC Staff.

Newspaper Publication and SAPA

NYSEG requests waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these revisions are "housekeeping" in nature and have no direct impact on NYSEG's electric customers.
