On July 29, September 26, and October 11, 2005, the Company submitted to the Commission its Second Competitive Transition Charge Reset Compliance Filing ("Second CTC Reset Filing") pursuant to Case No. 01-M-0075. This filing was submitted in compliance with the Company's obligation under its Rate Plan to reset the Competitive Transition Charges ("CTC"), recover a portion of the deferral balance associated with years five and six of the ten year Rate Plan, and implement and expand its Low Income Rate Discount Program.
