This filing is made in compliance with the Commission's Order Adopting Provisions of the Joint Proposal with Modifications, Cases 01-E-0359 and 01-M-0404, issued February 27, 2002, and the Order Directing Rate Design and Revenue Allocation, Case 01-E-0359, issued November 22, 2002, and the Order Adopting Economic Development Plan In Part And Providing For Further Proceedings, issued October 9, 2002, and the Order Modifying Economic Development Plan and Tariffs and Denying Rehearing, issued May 9, 2003, Case Nos. 01-E-0359 and 02-E-0576. The purpose of this filing is to set forth the Company's updated NYSEG Fixed Price (BRO) rates that become effective October 1, 2006.

The updated NYSEG Fixed Price (BRO) rates filed herein are the result of changes in the cost of fixed price service that have occurred since April 1, 2006. Customers who chose or were defaulted to the NYSEG Fixed Price (BRO) rate or the NYSEG Fixed Price with Supply Credit (BRO w/RAC) rate that became effective January 1, 2005, April 1, 2005, October 1, 2005 or April 1, 2006 and who remain on those rates, are not affected by the October 1, 2006 rate change filed herein.
