Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's gas tariffs.

Proposed Revisions

NYSEG is proposing to make the following tariff leaf revisions:

PSC 87:

Leaf Nos. 13.1 and 56 – Deleted references to Bill Mitigation Plan because the associated collections periods have been completed.

Leaf Nos. 52 and 53 – Added a "(1)" before the section entitled "Gas Delivery Charges".

<u>PSC 88:</u>

Leaf No. 3– Marked Section 19 as "Reserved for Future Use" because Service Classification 12 was previously cancelled, therefore the associated Service Agreement is no longer applicable. Corrected the titles of Sections 25 and 26 on Leaf No. 3 to correspond to the contents of those Sections on tariff leaves 50.13 and 50.15, respectively. Also, marked Sections 27 through 31 as "Reserved for Future Use" because the contents of these sections was previously replaced by the UBP Addendum.

Leaf No. 5 – Marked Service Classification No. 12 in the Table of Contents as "Reserved for Future Use". Service Classification 12 was previously cancelled.

Leaf No. 12.5 – Added "Cont'd" to the Section title.

Leaf Nos. 18 & 20 – Updated Company address in service agreement

Leaf No. 74 – Deleted Pipeline Supplier Adjustment which no longer exists.

Leaf Nos. 98.1 and 127 – Deleted references to Bill Mitigation Plan because the associated collections periods have been completed.

PSC 90:

Leaf Nos. 3.1, 90, 90.1 and 91 through 95 – Deleted references to Bill Mitigation Plan because the associated collections periods have been completed.

Leaf No. 7 – At 2.H.(1)(a) line 6, deleted "or less" after main greater than 4 inches.
