Re: Rochester Gas and Electric Corporation –
Further Revisions to Tariff Filing for Proposed Billing System Revisions

Dear Secretary Brillling:

The enclosed tariff leaves, issued by Rochester Gas and Electric Corporation (“RG&E” or “the Company”) are transmitted for filing in compliance with the requirements of the New York State Public Service Commission (“PSC” or “Commission”) and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H). The leaves are proposed to become effective on October 2, 2006. A listing of the proposed revised tariff leaves is enclosed as Attachment A.

Purpose of the Filing

The purpose of today’s filing is to make revisions to RG&E’s June 15, 2006, tariff filing. These revisions correct certain electric energy and demand prices that were inadvertently revised in the June 15 filing. The Company reiterates that the further unbundling of charges that was proposed in the June 15 filing for bill issuance and electric metering, whereby such charges could be separately stated on full service customer bills, was accomplished in a revenue neutral manner. Customer charges within each service classification have been reduced by the corresponding amount of the separately stated bill issuance and, where applicable, electric metering charges. There are no proposed changes to energy and demand charges currently in effect.

Additionally, PSC 19 Tariff leaves 199.1, 200, 200.1 and 200.2 of SC 8 are filed to reflect unbundling of economic development prices, consistent with the changes previously filed for the other Service Classifications. These leaves were inadvertently omitted in the June 15 filing. Also, natural gas tariff leaf 128 is filed to correct the charge for the first 3 therms, to reflect unbundling of the Bill Issuance Charge, consistent with tariff revisions previously filed for the other natural gas service classifications.

In accordance with the requirement of Section 66 (12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 as to newspaper publication, RG&E respectfully requests waiver of any additional newspaper publication because the substance of today's filed changes was included in the Newspaper Publication of RG&E's June 15, 2006 tariff filing.

Similarly, A State Administrative Procedure Act Notice is not enclosed because the substance of today's filing was included in the SAPA issued in association with the June 15, 2006 filing. Therefore, no additional SAPA is necessary.
