Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's electric tariffs in further compliance with the Commission's <u>Order Continuing the System Benefits</u> <u>Charge (SBC) and the SBC-Funded Public Benefit Programs</u>, issued and effective December 21, 2005 in Case 05-M-0090 ("SBC Order").

Proposed Revisions

The purpose of this filing is to consolidate changes that were made in compliance with the SBC Order with changes that were filed in three separate filings. Due to the timing of these filings and their effective dates, tariff revisions for each of the filings did not contain the rate that was filed in compliance with the SBC Order.

Since the SBC Order, the Company filed revisions to its tariffs implementing its new Customer Care and Service System in Case 05-E-0876. NYSEG also filed revisions that were "housekeeping" that became effective on May 22, 2006 in Case 06-E-0406. Lastly, the Company filed revisions in compliance with the Commission's Orders in Case 01-E-0359 to update its prices for the Bundled Rate Option that became effective on April 1, 2006.

The proposed revisions herein reflect the consolidation of these filings to ensure that the correct rate that was filed in compliance with the SBC Order becomes effective on July 1, 2006, as well as the changes that were filed in the three filings identified above.

Newspaper Publication

Per Ordering Clause 4 of the SBC Order, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of the changes proposed by this filing are waived.
