National Fuel Gas Distribution Corporation (“Distribution” or the “Company”) submits the following revised tariff leaves to P.S.C. No. 8 – GAS listed on Attachment A to this letter.

The proposed revision is issued as of today for an effective date of December 28, 2007.

Explanation of Filing

The purpose of this filing is to implement the proposed tariff effective December 28, 2007 to comply with the Commission’s *Order Establishing Rates for Gas Service* issued and effective December 21, 2007. A copy of this filing will be e-mailed to all active parties in this proceeding.

Rate design workpapers and rate calculations will be e-mailed to Commission Staff. Billing statements that are effective December 28, 2007 will be filed separately.

Beginning no later than June 27, 2008 the Company will bill suppliers who use the Company’s consolidated billing service FOR the \$1.07 billing and payment processing charge. This has been discussed with Commission Staff and is included in the Company’s tariff.

Notice to the public of the proposed change will be published once a week for four successive weeks, and proof of publication shall be filed with the Commission.
