Dear Secretary Brillling:

Rochester Gas and Electric Corporation ("RG&E", or the "Company") is filing herewith the following revised leaves to its Schedule for Gas Service - P.S.C. No. 16, Schedule for Electric Service Street Lighting - P.S.C. No. 18, and Schedule for Electric Service - P.S.C. No. 19 as a "housekeeping" change in compliance with the requirements of the Public Service Commission of the State of New York, to be effective March 1, 2004.

The housekeeping changes are necessary primarily to correct references or delete sections that are superseded as a result of RG&E's December 4, 2003 Tariff Filing in Compliance with the Commission's Order Adopting Recommended Decision with Modifications, Case Nos. 02-E-0198 and 02-G-0199, issued March 7, 2003 (the "March Order"), which provides for the transition to a multi-retailer model from a single-retailer model.
