The purpose of this filing is to implement a Renewable Portfolio Standard ("RPS") charge to fund above-market costs of renewable resources under the RPS program pursuant to the above referenced Order. The RPS charge will be a volumetric charge (per kWh) and will be applied to the energy deliveries on the bills of all full service and delivery service customers served under P.S.C. No. 15 - Electricity, excluding energy delivered by the Company which is supplied through a Power For Jobs allocation.

For billing purposes, the RPS charge per kWh will be combined with the System Benefits Charge ("SBC") per kWh, with the combined amount applied to applicable energy deliveries as discussed above. As a result, the RPS charge and

SBC will be shown as one line item on customer bills in compliance with the above referenced Order. The Statement of System Benefits Charge issued by the Company pursuant to General Information Section 36.A will be modified to include the RPS surcharge per kWh separately, and to provide a total SBC/RPS surcharge per kWh. As the RPS surcharge will not be effective prior to October 1, 2005, and the SBC is subject to update, on not less than 15 days notice to the Commission, it is the Company's intent to file a revised Statement of System Benefits Charge presenting the RPS charge on or before September 15, 2005.

Pursuant to Ordering Clause 7 of the above referenced Order, the requirements of 66(12)(b) of the Public Service Law as to newspaper publication of these amendments have been waived.
