Purpose

Ordering Paragraph 1 of the Commission's August 4, 2004 Order in Case 02-M-0515 required Niagara Mohawk and other gas utilities to file tariff leaves instituting firm delivery service for Residential Customers with Distributed Generation equipment within 90 days after the issuance date of the Order. The tariff leaves filed herein comply with Ordering Paragraph 1 of the above referenced order.

Revisions

Tariff Leaf Nos. 3, 93, 94, 95, 96, 97, 98, 122, 171, 176, 177 and 179 have been revised to reflect the addition of SC 13 to the appropriate Rule of the General Information Section of the Tariff. In addition, Tariff Leaf

No. 93 reflects the addition of a Load Factor Multiplier of .61 for use in calculating the Monthly Cost of Gas Rate applicable to SC 13 customers taking commodity service from the Company.

Tariff Leaf Nos. 216, 216.1, 216.2, and 216.3 reflect the addition of Service Classification No. 13 – Residential Distributed Generation Service.

Tariff Leaf No. 230 has been revised to incorporate the Company's right to install an Approved Remote Meter at the Company's expense, with the customer supplying access to an electrical supply and a phone line.

Advertising

Newspaper publication of the proposed tariff changes has been waived in accordance with Ordering Paragraph 5 of the August 4, 2004 Order.
