This filing is made in further compliance with the Company's June 30, 2004 Phase 2B Joint Proposal, as approved by the PSC in its Order Concerning Rate Design, Economic Development, and Affordable Energy Program, Case 01-G-1668, issued September 23, 2004 (the "Order").

The Phase 2B Joint Proposal included a five-year phase-in to the new non-residential delivery rates in all areas where we had customers taking service under a class. Pursuant to Section XI.1. however, the SC-1T delivery rates applicable for service in areas where no customers were taking service under SC-1T would be set equal to the delivery rates to be effective October 1, 2008 in the Combined Area and the Lockport Area. Subsequent to the Company's June 30, 2004 filing in compliance with the Order, it was discovered that one customer in the Owego area had switched to SC-1T prior to the filing of the Phase 2B Joint Proposal. Since the intent of the Joint Proposal was to phase-in delivery rates in those areas where there were customers, the filing herein includes SC-1T delivery rates to be effective October 1 of each of each year beginning in 2004 through 2008. Consistent with Section VI. 2 of the Gas Rate Plan, these rates

will continue beyond December 31, 2008 unless and until changes to the terms and conditions of the Joint Proposal have been approved by the Commission.

Based on discussions with Staff, the Company has also incorporated herein several "housekeeping" changes to leaves that were previously filed in compliance with the Order.
