Customers who chose or were defaulted to the NYSEG Fixed Price (BRO) rate or the NYSEG Fixed Price with Supply Credit (BRO w/RAC) rate that became effective January 1, 2003, April 1, 2003, October 1, 2003, or April 1, 2004, and who remain on those rates, are not affected by the October 1, 2004 rate change filed herein.
