Purpose

The purpose of this filing is to comply with Paragraph 1.6.7.1 and 1.6.7.5 of the Company's Joint Proposal filed on October 11, 2001 in Case 01-M-0075 and approved by the Commission in Opinion 01-6 issued and effective December 3, 2001.

Explanation of Filing

Miscellaneous Tariff and Rate Design Issues

Paragraph 1.6.7.1 provides for certain rate design changes to become effective September 1, 2004. Specifically, paragraph 1.6.7.1 calls for the minimum charge for SC1 Non-Heating customers to be increased by \$1.48 from \$13.07 to \$14.55 monthly effective September 1, 2004. For heating customers, paragraph 1.6.7 calls for the minimum charge to remain unchanged at \$14.55. The increase in the customer charges is to be implemented on a revenue-neutral basis by reducing the unit rate in the first block after the minimum charge. However, the rates as stated in the Joint Proposal Paragraph 1.6.7.1 did not contemplate the effect of the Roll-In of State Net Income Taxes to delivery rates implemented September 1, 2003 as provided for in Paragraph 1.6.1.2. Therefore, the minimum charge for SC1 non-heating customers is proposed to be increased by \$1.51 effective September 1, 2004 from \$13.20 to \$14.71. A reduction of (\$0.00388) from \$0.35309 to \$0.34921 has been made to the first block after the minimum charge negating the customer charge increase. As proposed, the SC1 Non-Heat delivery rate design becomes equal to the SC1 Heat delivery rates effective September 1, 2004 as originally contemplated in the Settlement Agreement.

Finally, the filing includes changes for former Syracuse Suburban Gas Company customers as provided for by Paragraph 1.6.7.5. Paragraph 1.6.7.5 provides for the implementation of a \$350.00 administrative charge for the first 100 therms or less for former customers of Syracuse Suburban Gas Company taking service on SC6 to be effective September 1, 2004. Furthermore, in continuation of a process set out in the Gas Settlement in Case 99-G-0336, Paragraph 1.6.7.5 allows for rate changes to implement the fifth step of a six year phase-in of the delivery rates applicable to former Syracuse Suburban Gas Company customers taking SC1, SC2 and SC5 gas service to be effective September 1, 2004. All incremental revenue resulting from the process to eliminate the Niagara Mohawk/Suburban rate differential will continue to be credited to the Company's Gas Contingency Reserve Account.
