As a result of recent discussions with Department of Public Service Staff, NYSEG is submitting this additional filing in further compliance with the Order. Attached are tariff revisions to PSC Nos. 88 and 90 – Gas, which reflect the following:

- 1) Minor housekeeping changes;
- 2) Clarification to the "Reconciliation of Volumes" description in General Information Section 5, Non-Daily Metered Transportation Requirements, D. Balancing of Receipts and Deliveries, to specify the October/November and April/May timing of the reconciliation which is dependent upon the customer's actual meter read (See Leaf No. 13.3, PSC No. 88); and
- 3) The inclusion of a component to the "PRICE" description of the monthly Demand Charge that was inadvertently omitted under the new Service Classification No. 17, Daily Metered Transportation Daily Balancing Service (See Leaf No. 116, PSC No. 88).
