The purpose of this filing is to modify the Company's gas tariff so that operating issues that are unique to Central Hudson's Retail Access Program are included in General Information Section 41 of the Company's gas tariff. All operating issues which are generic to New York State's Retail Access Program are addressed in the New York State Public Service Commission's Uniform Business Practices which has been included as an addendum to the Company's gas tariff.

In addition, as directed by Ordering paragraph two of the Commission's December 5, 2003 Order in this Case, Central Hudson has included in this filing the Company's tariff revisions setting forth the proposed method to calculate the alternate payment amount to end a Retail Supplier initiated suspension of a residential customer's delivery service.

As directed by Ordering paragraph one, copies of these tariff leaves were sent to all active parties in this Case.

As directed in Ordering paragraph four of the Commission's December 5, 2003 Order in this Case, the requirements of 66(12)(b) of the Public Service Law as to newspaper publication have been waived. Questions related to this filing should be directed to Patricia M. Buck at (845) 486-5244.
