Re: Case 05-E-0876 - New York State Electric & Gas Corporation –
Supplemental Tariff Filing for Proposed Billing System Revisions

Dear Secretary Brillling:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation (“NYSEG” or “the Company”) are transmitted for filing in compliance with the requirements of the New York State Public Service Commission (“PSC” or “Commission”) and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H). The leaves are proposed to become effective on January 1, 2006. A listing of the tariff leaves is enclosed as Attachment A.

Purpose of the Filing

On July 20, 2005, NYSEG filed tariff changes to conform the tariff to the billing specifications of NYSEG’s new billing system: Customer Care and Service System (“CCS”). In the July 20 filing letter, within the paragraph entitled “Unbundling of the NYSEG Fixed Price”, NYSEG stated that it would later file revised NYSEG Fixed Price (“BRO”) tariff leaves to incorporate the October 1, 2005 BRO price changes. Those originally filed leaves contained only the January 1, 2005 and April 1, 2005 BRO prices. The purpose of today’s filing is to add the October 1, 2005 BRO prices to the leaves originally filed on July 20, 2005 in Case 05-E-0876. Today’s revisions contain no changes to the methodology by which BRO prices were unbundled in the July 20, 2005 filing.

NYSEG is also filing Cancellation Supplement No. 2 to PSC 120 to cancel two Service Classification (“SC”) 11 tariff leaves that were inadvertently included in the July 20, 2005 filing. As stated in NYSEG’s July 20, 2005 filing letter, the grandfathered prices within SC 11 are not proposed to be unbundled. Therefore, filing of tariff leaf nos. 294.8 and 294.9 to PSC 120 was not needed and NYSEG proposes to cancel those tariff leaves.

Newspaper Publication & SAPA

In accordance with the requirement of Section 66 (12)(b) of the Public Service Law and 16

NYCRR Section 720-8.1 as to newspaper publication, NYSEG respectfully requests waiver of any additional newspaper publication because the substance of today's filed changes was included in the Newspaper Publication of NYSEG's July 20, 2005 tariff filing. NYSEG filed proof of publication of the July 20, 2005 tariff filing by letter dated October 7, 2005.

Similarly, A State Administrative Procedure Act Notice is not enclosed because the substance of today's filing was included in the SAPA issued in association with the July 20, 2005 filing. Therefore, no additional SAPA is necessary.
