### Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's electric tariffs.

# **Proposed Revisions**

NYSEG is proposing to make the following PSC 120 tariff leaf revisions:

Leaf 1 - Correct the Company name from "New York State Gas and Electric Corporation" to "New York State Electric & Gas Corporation".

Leaf 28 – Correct the section references for definitions of Large and Small customers from "Section 12.E." to "Section 12.C."

Leaf 59 – Correct the last sentence of Section 16.D.1(e) to say that the NYPA load (not the non-NYPA load) will be billed at the appropriate NYPA rate.

Leaf 76 – Correct the title of Section 16. D. 13. to be consistent with the previous page. Correct the sequential lettering of Section 16.D.13 (a) through Section 16.D.13 (d).

Leaf 110 – Delete the reference to the (expired) Price Cap Period.

Leaves 117.4 & 117.5 – Correct the Section number and title on each tariff leaf.

Leaf 134 - Correct the late payment charge from 1% to 1 ½%, consistent with the text description of that percentage.

Leaves 134 and 221 - Correct the phrase "...the billing demand will be 95% of the metered demand" to state: "...the metered demand will be 95% of the metered demand". The word "metered" in this phrase was inadvertently revised to say "billing" on Leaf No. 21 of PSC 115, effective on May 1, 2000. No such change was authorized by the PSC or intended by NYSEG.

Leaf 219 - Align the on and off-peak prices with the on and off-peak energy charge rows.

Leaves 311 and 319 – Correct the effective date within the body of each leaf to read "September 29, 2005" rather than "August 29, 2005", consistent with Postponement Supplement No. 1 that postponed the effective date of the leaf to September 29, 2005.

#### Newspaper Publication and SAPA

NYSEG requests waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these "housekeeping" revisions have no direct impact on NYSEG's electric customers.
