Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's gas tariffs.

### Proposed Revisions

The purpose of this filing is to remove language from the description of the Gas Supply Charge Calculation that now indicates that the Research and Development Adjustment (“R&D Adjustment”) is a part of that calculation and instead, to list the R&D Adjustment as part of the Delivery Charges within NYSEG’s Sales tariff to be applied to customer bills<sup>1</sup>.

The R&D Adjustment was unbundled from the Gas Supply Charge when the Company implemented its new billing system. Effective with the implementation of the new billing system, the R&D Adjustment started appearing as a line item on customers’ bills. The proposed revisions reflect how customers are being billed the R&D Adjustment.

### Newspaper Publication and SAPA

NYSEG requests waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these “housekeeping” revisions have no direct impact on NYSEG’s gas customers.
