## **Explanation of Filing**

Pursuant to the Joint Proposal in Case 06-G-1332 ("Joint Proposal"), adopted by the Gas Rates Order, and to the Commission's "Order Continuing Revenue Decoupling Mechanism," issued and effective May 19, 2009 ("Gas RDM Continuation Order") provided that if, during any Rate Year the Company projects that the combined annual reconciliation of the RDM for all groupings will

equal or exceed \$10 million, the Company will implement interim surcharges or refunds by grouping, subject to further reconciliation at the end of the Rate Year.

Based on current projections, the Company estimates that the combined annual reconciliation of all groupings will result in an overall surcharge at the end of Rate Year 3 of approximately \$30.6 million. This overall surcharge consists of projected pure base revenue shortfalls for Rate Year 3 of \$6.6 million for the SC 2 Heating grouping, \$5.3 million for the SC 2 Non-Heating grouping, \$24.9 million for the SC 3 1-4 dwelling units grouping, and a proposed pure base revenue over collection of \$6.2 million for the SC 3 > 4 dwelling units grouping. As a result, the Company, by this filing, is implementing, effective January 1, 2010, interim surcharges of 2.1177¢ per therm, 3.1619¢ per therm, and 8.6127¢ per therm, for the SC 2 Heating, SC 2 Non-Heating, SC 3 1-4 dwelling units groupings, respectively, and an interim refund of 2.1964 ¢ per therm for SC 3 > 4 dwelling These surcharges and refund, when added to the RDM units grouping. adjustments currently in effect for Rate Year 2 will result in surcharges of 4.2481¢ per therm, 5.513¢ per therm, 14.8421¢ per therm for the SC 2 Heating, SC 2 Non-Heating, and SC 3 1-4 dwelling units groupings, respectively, and a refund of 3.09¢ per therm for the SC 3 > 4 dwelling units grouping. The interim surcharges and refund are designed to be in effect from January 2010 through December 2010, except that as provided for in the Joint Proposal and the Gas RDM Continuation Order, the surcharges will be subject to further reconciliation at the end of Rate Year 3, when actual shortfalls and excesses are known.
