## Purpose of the Filing

In compliance with Ordering Clause 2 of the September 22 Order, NYSEG is filing tariff revisions to set forth revised rates for reactive charges and to modify the power factor level. The reactive rates and power factor level will be applied to customer bills when the customer's metered demand is greater than 200 kW in any two of the previous twelve months.
