In accordance with the Public Service Commission of the State of New York's ("Commission") "Order Approving Transportation and Balancing Collaborative Report Recommendations with Modifications" dated June 23, 2009 ("June 23rd Order"), The Brooklyn Union Gas Company d/b/a National Grid NY ("KEDNY") hereby submits one copy of the revised tariff leaves listed in Appendix A issued by KEDNY to its Schedule for Gas Service, PSC No. 12 on December 1, 2009 to become effective on a temporary basis on December 2, 2009. After discussions with Staff, it has been agreed that further revisions were necessary to the aforementioned leaves.

Specifically the Company is modifying its tariff to: 1) include the concepts of balancing and swing services for power generators that enter new service agreements or renew or renegotiate existing service agreements with the Company; and 2) align the KEDNY tariff with the KeySpan Gas East Corporation d/b/a National Grid ("KEDLI") tariff to include provisions that address roles, responsibilities and charges when there is a failure of the telemetering equipment or the data is faulty.

In the course of these discussions with Staff, KEDNY has deemed it necessary to also make housekeeping changes. These changes are contained on Appendix B.
