**RE: CASE 06-G-1186 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of KeySpan Gas East Corporation d/b/a National Grid – Transportation and Balancing Collaborative**

Dear Secretary Brilling:

In accordance with the Public Service Commission of the State of New York's ("Commission") "Order Approving Transportation and Balancing Collaborative Report Recommendations with Modifications" dated June 23, 2009 ("June 23rd Order"), KeySpan Gas East Corporation d/b/a National Grid ("KEDLI") hereby submits one copy of the revised tariff leaves listed in Appendix A issued by KEDLI to its Schedule for Gas Service, PSC No. 1 on December 1, 2009 to become effective on a temporary basis on December 2, 2009. After discussions with Staff, it has been agreed that further revisions were necessary to the aforementioned leaves.

Specifically the Company is modifying its tariff to: 1) include the concepts of balancing and swing services for power generators that enter new service agreements or renew or renegotiate existing service agreements with the Company; and 2) include new end-of-month cash out provisions for non-core transportation customers served under Service Classification Nos. 7 and 13.

In the course of these discussions with Staff, KEDLI has deemed it necessary to also make housekeeping changes. These changes are contained on Appendix B.
