Dear Secretary Brillling:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation (“NYSEG” or “the Company”), are being transmitted for filing in compliance and accordance with Appendix 7-H (electronic tariff filing system) of the New York State Public Service Commission’s (“PSC” or “Commission”) Codes, Rules and Regulations (16 NYCRR Appendix 7-H). Appendix A sets forth a list of the revised tariff leaves. The tariffs are filed to become effective on October 17, 2009.

Purpose of the Filing

The enclosed revisions to the Company’s Schedules for Electric Service, PSC No. 120 – Electricity, and PSC No. 121 – Electricity, are designed to produce an annual increase in electric revenues of \$169,700,000.

The enclosed revisions to the Company’s Schedules for Gas Service, PSC No. 87 – Gas, and PSC No. 88 – Gas Transportation, are designed to produce an annual increase in gas revenues of \$63,400,000.

Prepared written testimony and exhibits comprising NYSEG’s direct case in support of these tariff revisions is being filed contemporaneously, under separate cover.

Newspaper Publication

Notice of this filing will be published in newspapers in accordance with the Commission's requirements set forth in 16 NYCRR §§ 720-8.1 and 270.70. Proof of publication of the notice will be filed upon completion. In addition, the Company will issue appropriate bill inserts in accordance with 16 NYCRR §§ 720-9.1 and 270.80.
