New York State Electric & Gas Corporation ("NYSEG" or the "Company") hereby submits for filing the following enclosed tariff leaves in compliance with Ordering Paragraph 1 of the New York Public Service Commission's (the "Commission") Order Modifying and Authorizing Wind Net Metering Tariffs, Case No. 09-E-0296, issued and effective June 22, 2009 (the "Order") and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

Description of Tariff Revisions

Payments to Residential Customers

The Company is revising its tariffs to conform the form of payment for residential customers to the form of payment for farm service customers. Residential customers will receive a cash payment for any excess generation that has accumulated on the customer's account at the end of a year.

Metering Costs

NYSEG has revised its tariffs to state the responsibility of meter costs for customers with generators that are equal to or greater than 25kW in which the Company has determined a second meter to be necessary. The customer will be responsible for

one-half of any interconnection costs, including costs for the second meter and installation costs.

Farm Service Definition

NYSEG has clarified the definition of an eligible farm service customer. The farm on which the wind generator is sited must also be the location of the customer's primary residence.

Housekeeping

NYSEG is also including a housekeeping change to Leaf No. 284. This leaf was revised in compliance with Public Service Law Section 66-1 and then further revised in compliance with the Commission's <u>Order Continuing and Modifying in Part the Standby Rate Exemption</u>, issued and effective May 18, 2009, in Case 09-E-0109. The tariff revisions reflected herein consolidate the two compliance filings.

Newspaper Publication

In accordance with Ordering Paragraph 4, the requirement of § 66(12)(b) of the Public Service Law regarding newspaper publication is waived.
