Leaf No. 37 is issued by Central Hudson Gas & Electric Corporation ("the Company") and transmitted for filing in compliance with the requirements of the Public Service Commission of the State of New York in Case 92-M-0607.

P.S.C. No. 15 - Electricity

10th Revised Leaf No. 37

This amendment is issued March 26, 2009 to become effective July 1, 2009. The purpose of this filing is to update the rates used in determining contributions required from applicants for underground extensions in new residential subdivisions. The rates used in determining contributions required from applicants proposed with this filing reflect a five-year average of actual calendar-year data.

The tariff changes to the cost per trench foot of URD service are as follows:

	Present	Proposed
Overhead Supply Lines	\$ 28.78	\$ 31.40
Underground Supply Lines	10.60	11.55
Underground Distribution Lines	13.33	14.47
Underground Service Lines (a)	11.83	12.97

(a) The average cost per foot of service lines installed excludes the cost of trenching. Therefore, the proposed tariff rate for underground service lines is based on the proposed underground distribution rate less the estimated cost differential between distribution line trenching (\$4.50 per foot for 36" trench depth) and service line trenching (\$3.00 per foot for 24" trench depth).

Effective July 1, 2008 the credit applicable to trenching underground distribution and services in residential subdivisions for electric only service installations was set at \$7.95 per foot, while the credit applicable for combination electric and gas service installations in a common trench was set at \$12.75 per foot. In all cases, excluding two instances where rock was present, the then current "trenching credit" was accepted by the on-site excavator(s). Therefore, the Company proposes to leave these rates unchanged.

The new rates detailed above will become effective July 1, 2009 and will remain in effect through June 30, 2010.

The Company is arranging to comply with the requirements of 66(12)(b) of the Public Service Law by publishing notices of the rate changes proposed herein in the April 8, 15, 22, and 29, 2009 issues of the Catskill Daily Mail, the Kingston Freeman, the Times Herald Record and the Poughkeepsie Journal.
