The attached System Benefits Charge ("SBC") Statement issued by Niagara Mohawk Power Corporation, d/b/a National Grid is being transmitted for filing in compliance with the order ("Order") in the above case numbers issued and effective December 30, 2010.

Statement of System Benefits Charge No. 6

To P.S.C. No. 220 Electricity

Effective: February 1, 2011

The purpose of this filing is to establish Statement of System Benefits Charge No. 6 in accordance with Rule No. 41-Adjustment to Charge Pursuant to the System Benefits Charge (SBC).

In the above Order the Commission approved a six month extension of SBC III and authorized the transition of SBC energy efficiency resource acquisition programs to the EEPS portfolio. Also, as directed in this Order, the SBC III collections currently scheduled for 2011 are to be deferred to 2012 and 2013 and the SBC III assessment is to be reduced to zero for 2011. SBC III collections for 2011, which commenced on January 1, 2011, will be retained in the manner directed in Ordering Clause No. 1 until transferred to the New York State Energy Research and Development Authority ("NYSERDA"). Ordering Clause No. 1 also directed all utilities affected by this order to file tariff amendments and/or statements on not less than 5 day's notice to become effective February 1, 2011.

The attached statement complies with this Order and sets the SBC III factor to (\$0.000037) beginning February 1, 2011, which represents the remaining amount of the actual over collection of SBC III revenues for calendar year 2010 of \$916,021 as shown on Attachment 4. This amount will be credited back to customers over the remaining eleven months of 2011.

The SBC III Factor of (\$0.000037) will be added to the EEPS SBC factor of \$0.003361 effective January 1, 2011 as filed with the Commission on December 22, 2010. Therefore, the total factor effective February 1, 2011 on customer's bills is \$0.003324.
