More specifically, the Company is filing a revision to the Gas Reliability Surcharge to reflect a change in the calculation, if necessary, to reflect the storage inventory working capital carrying costs<sup>1</sup>. RG&E is also filing to remove "PSC" from the label for Transition Charge in its gas tariffs.

Additional revisions are being made to correct typographical errors in its electric tariff, PSC No. 19.
