Purpose of the Filing

The purpose of this filing is to revise Rule No. 53 – Standardized Interconnection Requirements and Application Process for New Distributed Generators 2MW or Less Connected in Parallel to Utility Distribution Systems in PSC No. 220 Electricity in compliance with the above order. Ordering Clause No. 3 directed the Company to file tariff amendments that comply with the revised Standard Interconnection Requirements (SIR) to reflect the amendments to PSL 66-j and 66-l, enacted on March 16, 2010, that eliminated the peak load size limitation of a non-residential customer's solar or wind electric generating equipment and revised the cost responsibility for dedicated transformer(s) or other equipment necessary for safety and adequacy of service. This ordering clause also directed that these revisions are to be effective on one day's notice on July 23, 2010.

In accordance with Ordering Clause No. 2 of this order, the requirements of §66(12)(b) of the Public Service Law as to newspaper publication are waived for this filing.
