In accordance with Section 720-2 et al. of the Commission's Regulations, 16 NYCRR § 720-2 et al., The Brooklyn Union Gas Company d/b/a National Grid NY ("National Grid" or "Company"), hereby submits the tariff leaves contained on Attachment A to become effective October 1, 2010.

The purpose of this filing is to amend the Company's tariff to add and clarify the requirements and obligations of customers, including the following:

- Leaf 159 and 163 Sole source language and government mandates Leaf 162 and 165 Add requirement that customers voluntarily switching must remain on the firm rate for 12 months
- IT and TC tariffs Clarification of test language; provides that any test failure would be considered a violation
- Termination language Clarification
- Additional charge Amends the penalty charge for unauthorized use, adding the permitted two therms.
- Leaf 224 Clarification as to notice of failure and obligation to remedy.
- Leaf 224.1 Clarification of the non-compliance charge and simultaneous billing of the Additional Charges.
- Leaf 225 Clarification as to consequences of two violations.
- Leaf 381.1 and 381.2 Add non-compliance charge language to the non-core transportation tariff.
