Dear Secretary Brilling:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E") (together the "Companies") are transmitted for filing in compliance with the requirements of the New York Public Service Commission's (the "Commission") Order Adopting Revised Gas Supply Procedures and Requirements and Directing Tariff Filings issued and effective October 18, 2012 ("the Order"). These tariff leaves are transmitted for filing in compliance as identified herein and in accordance with the requirements of Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

Purpose of the Filing

The Companies are filing tariff amendments in compliance with Ordering Clause 2 of the Order to effectuate changes to the gas supply procedures and requirements as discussed in the Order.

Overview of the Filing

The Companies' August 3, 2012 petition requested authorization to adopt certain gas supply collaborative proposals, which includes the following:

- Consolidating the remaining two NYSEG gas supply areas ("GSA") into a single GSA effective September 1, 2013. The GSA consolidation will apply to the Gas Supply Charge, Merchant Function Charge, Transition Surcharge and the Reliability Surcharge. Transportation Balancing Charges will be consolidated over a phase-in period beginning September 1, 2013 and concluding April 1, 2014;
- Adopting a system-wide weighted average cost of capacity for the release of capacity to ESCOs, to be accomplished over a phase-in period beginning April 1, 2013 and concluding April 1, 2014;
- · Amending the NYSEG and RGE tariffs to clarify the Companies right to collect incremental upstream pipeline costs beyond the 10% balancing threshold.

In accordance with the Order, the proposed recommendations may be implemented as discussed in the body of the Order.

Publication

In compliance with Ordering Clause 3 of the Order, the requirements of 66(12)(b) of the Public Service Law requiring newspaper publication has been waived.
