Re: Additional Tariff Filing to Reflect Comments from Staff

Dear Secretary Brilling:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E") (together the "Companies") are transmitted for filing in compliance with the requirements of the New York State Public Service Commission ("PSC" or "Commission") and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

On July 30, 2012, the Companies proposed revisions to its tariffs to make the language consistent for certain tariff provisions. After further discussion with the Department of Public Service Staff, the Companies are proposing additional tariff revisions to correct minor grammatical or numerical errors and add clarifying language where necessary. A listing of the proposed revised tariff leaves is enclosed as Attachment A.

The Companies reiterate its request that the requirement of 66(12)(b) of the Public Service Law and 16NYCRR 720-8.1 as to newspaper publication be waived because the revisions do not affect any internal procedures or processes, and will not directly impact the Companies' customers.
