RE: Case 11-E-0319, Net Metering

Dear Secretary Brilling:

Consolidated Edison Company of New York, Inc. (“Con Edison” or the “Company”) is filing with the New York State Public Service Commission (the “Commission”) amendments to its Schedule for Electricity, PSC No. 10 – Electricity, applicable to its customers in the City of New York and the County of Westchester.

The tariff leaves, which are identified in Appendix A, are issued to become effective on April 1, 2012.

Reason for Filing

On December 20, 2011, the Company made a tariff filing to expand Rider R (“Net Metering for Customer-Generators”) of P.S.C. No. 9 – Electricity to residential and non-residential customers having micro-hydroelectric generating equipment and to non-residential customers having fuel cell generating equipment. On February 13, 2012, the Company filed an additional change to Rider R. Subsequent to issuance of the two filings, P.S.C. No. 9 – Electricity was superseded by electronic rate schedule, P.S.C. No. 10 – Electricity (“P.S.C. No. 10”).

The Commission issued an Order, issued and effective March 16, 2012, in Case 11-E-0319 (the “Order”), approving the Company’s tariff filings made December 20, 2011 and February 13, 2012. The Order directed the Company to incorporate the amendments filed on December 20, 2011 and February 13, 2012, into P.S.C. No. 10.¹ The Order also directed the Company to file the Commission’s updated “Standardized Interconnection Requirements” (“SIR”) as an addendum to P.S.C. No. 10.

¹ By separate letter, the Company is issuing Supplement No. 92 to P.S.C. No. 9 – Electricity to cancel the tariff leaves filed to P.S.C. No. 9 on December 20, 2011 and February 13, 2012. Supplement No. 92 has an effective date of April 1, 2012.

Tariff Changes

As directed by the Order, the Company is incorporating the approved tariff changes into P.S.C. No. 10. The Company is filing Addendum-SIR-3 to P.S.C. No. 10 to reflect the Commission's updated SIR.

Conclusion and Notice

As directed by Ordering Clause 3, the SIR is filed on not less than three days' notice, and as directed by Ordering Clause 4, revisions to P.S.C. No. 10 are filed on not less than one day's notice, to become effective on April 1, 2012. Ordering Clause 2 of the Order waived newspaper publication of this filing.
