Re: Case 08-E-0539, New Electricity Rate Schedules, P.S.C. No. 11 – Electricity and P.S.C. No. 12 - Electricity

Dear Secretary Brilling:

On November 22, 2011, Consolidated Edison Company of New York, Inc. (the "Company") made a tariff filing with the Public Service Commission (the "Commission"), proposing a new electricity rate schedule, Schedule for Economic Development Delivery Service ("EDDS"), P.S.C. No. 11 – Electricity, applicable to delivery service to the Power Authority of the State of New York ("PASNY or NYPA"), the New York City Public Utility Service ("NYCPUS"), and the County of Westchester Public Utility Service Agency ("COWPUSA"). Also, on November 23, 2011, the Company made a tariff filing with the Commission proposing a new electricity rate schedule, Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity, applicable to delivery of power and associated energy to customers of NYPA. P.S.C. No. 11 supersedes EDDS No. 2, and P.S.C. No. 12 supersedes PASNY No. 4. New rate schedules

FitzPatrick Power Project" between the County of Westchester, acting through COWPUSA, and the Company, made April 24, 1987, and (3) the "Agreement between the City of New York and Consolidated Edison Company of New York, Inc., for the Delivery of Power and Energy from the James A. FitzPatrick Nuclear Power Project" between the City of New York, acting through NYCPUS, and the Company, made October 23, 1987.

<sup>&</sup>lt;sup>3</sup> The Company was required to convert its electric tariffs to an electronic format using the Department of Public Service Electronic Tariff System, pursuant to the Commission's <u>Order Setting Electric Rates</u>, issued April 24, 2009, in Case 08-E-0539 and the Joint Proposal (page 43) that was adopted by the Commission's <u>Order Establishing Three-year Electric Rate Plan</u>, issued March 26, 2010, in Case 09-E-0428. As specified in the Joint Proposal, the Company was required to complete the conversion prior to the end of Rate Year 2, which ends March 31, 2012.

P.S.C. No. 11 – Electricity and P.S.C. No. 12 – Electricity become effective on February 20, 2012, pursuant to the Commission's Order issued and effective February 16, 2012, regarding "Tariff filings by Consolidated Edison Company of New York, Inc. to replace its electric tariff schedules with electronic tariff schedules compatible with the Commission's Electronic Tariff System" (the "Order").

As directed by the Order, the Company is filing conforming tariff changes and Statements to become effective on February 20, 2012. The Company is also filing a housekeeping change. The tariff leaves and Statements are identified in Appendix A. The changes are described below.

## Changes

Because Leaf No. 12 of P.S.C. No. 11 and Leaf No. 19 of P.S.C. No. 12 referred to November 1, 2011, the effective date originally proposed for P.S.C. No. 11 and P.S.C. No. 12, the Company has modified those leaves to reflect the change in the Schedules' effective date to February 20, 2012. The Company has also made a housekeeping change to Leaf No. 12 of P.S.C. 11, replacing the word "made" with "may" in the definition of "Schedule for Electricity."

The Company is filing Statements to P.S.C. No. 11 that contain the monetary amounts that were formerly filed in EDDS No. 2. The P.S.C. No. 11 Statement types are as follows: GRT-EDDS; RAC-EDDS; PSL-EDDS; and SGRID-EDDS. The Company is also filing Statements to P.S.C. No. 12 that contain the monetary amounts that were formerly filed in PASNY No. 4. The P.S.C. No. 12 Statement types are as follows: GRT-PASNY; RDM-PASNY; RAC-PASNY; PSL-PASNY; and SG PASNY.

## Conclusion and Notice

As directed by Ordering Clause 2, the tariff leaves and statements specified in Appendix A are issued on not less than one day's notice, to become effective on February 20, 2012. As directed by Ordering Clause 3, the Commission has waived newspaper publication of these changes.
