Overview

Chapter 61 of the Laws of 2011 amended Section 66 of the Public Service Law (PSL) by adding a new subdivision 12-d regarding a special excelsior jobs program.

The Notice provided that for those utilities with gas and electric service Empire Zone rates in accordance with NY PSL 66(12-c), such utilities should file proposed Excelsior Jobs tariff delivery rates equal to their existing Empire Zone delivery rates. The Companies previously submitted proposed Excelsior Jobs Program tariff rates for certain electric service classifications where the Companies have existing Empire Zone delivery rates. The instant filing is being submitted to update the Companies filing dated February 14, 2012.

Publication

The Companies respectfully request the requirements of Section 66(12)(b) of the Public Service Law regarding newspaper publication be waived as these changes will not affect the majority of the Companies' customers.
