Effective: June 1, 2012

On March 31, 2011, Chapter 61 of the Laws of 2011 amended New York State Public Service Law Section 66 by adding a new subdivision 12-d regarding a special Excelsior Jobs Program rate, equal to the incremental cost of providing service to participants in this program as defined in Article Seventeen of the Economic Development Law. The above notice directed the listed utilities to file tariff amendments necessary to conform their tariffs to these new statutory requirements by February 14, 2012 to become effective June 1, 2012. On February 14, 2012 a further notice was received granting an extension of this filing to February 29, 2012.

The above leaves comply with notice and set forth Rule 34 – Program 6-Excelsior Jobs Program ("EJP"). As directed by this notice, the rates contained in this filing for the Excelsior Jobs Program equal the existing Empire Zone delivery rates, which are equal to the incremental cost of providing service. As outlined in Rule No. 34.7.4.2, EJP load shall be subject to all surcharges and adjustments of the customer's otherwise applicable parent service classification but will not be subject to Rule 57 – Revenue Decoupling Mechanism.

Waiver of the requirements of newspaper publication as required by the Commission's regulations at 16 NYCRR Section 720-8 is requested for this filing, because customers will apply to and be certified by the NYS Department of Economic Development for their eligibility for this program and the Department of Economic Development already has begun to implement this program.
