Overview

Chapter 61 of the Laws of 2011 amended Section 66 of the Public Service Law (PSL) by adding a new subdivision 12-d regarding a special excelsior jobs program. Participants in the excelsior jobs program, as defined in article seventeen of the economic development law, will receive discounted rates that are equivalent to the incremental cost of providing service.

The Notice further provided that for those utilities with gas and electric service Empire Zone rates in accordance with NY PSL 66(12-c), such utilities should file proposed Excelsior Jobs tariff delivery rates equal to their existing Empire Zone delivery rates.

The Companies have proposed Excelsior Jobs Program tariff rates for certain electric service classifications where the Companies have existing Empire Zone delivery rates. The Companies are not proposing Excelsior Jobs Program delivery rates for its gas service classifications since the standard delivery rates are at or below marginal costs.

Publication

The Companies respectfully request the requirements of Section 66(12)(b) of the Public Service Law regarding newspaper publication be waived as these changes will not affect the majority of the Companies' customers.
