Overview of the Filing

In compliance with ordering clause 2 of the Order, the Companies are submitting changes to its tariffs as described herein. The Order requires utilities to file tariff revisions to implement the revisions to Public Service Law that became effective September 23, 2011. The revisions to Public Service Law Section 66-j provide for the net metering of micro-hydroelectric and fuel cell generating facilities¹.

NYSEG and RG&E are also including a revised Standardized Interconnection Requirements (SIR) Addendum in compliance with ordering clause 4 of the Order.

Publication

In compliance with ordering clause 5 of the Order, newspaper publication is waived because existing non-residential and farm customers affected by these tariff changes will be notified directly. New customers will be advised of these tariff changes when they enter into interconnection agreements with the Company.

¹ Currently, the Companies' tariffs allow a residential customer to install a fuel cell with a rated capacity up to 10 kW and participate in net metering. The revisions to Public Service Law 66-j expand the eligibility to non-residential customers installing fuel cells with a rated capacity up to 1,500 kW and be able to participate in net metering.
