On behalf of Kiebler Water Services, Inc., ("Kiebler Water") and in compliance with the Commission directive in Case 06-W-0558, issued and effective April 22, 2008 (the "Order"), I enclose the following documents:

- In accordance with ordering clause 3 of the Order, Kiebler Water hereby submits a copy of the Water Bill of Sale and Assignment Agreement by and between Peek'n Peak Water Services, Inc. and Kiebler Water dated as of June 8, 2006, by which the water system assets have been transferred and conveyed to Kiebler Water as of January 14, 2009.
- In accordance with ordering clause 4 of the Order, Kiebler Water hereby submits the Adoption Supplement by which Kiebler Water adopts the tariff schedule of Peek'n Peak Water Services, Inc., which supplement is effective as of April 1, 2009.
- In accordance with ordering clause 4 of the Order, Kiebler Water hereby submits a Request to Replace Tariff dated as of February 11, 2009 and signed by the Secretary of Kiebler Water to request permission to convert from a paper to an electronic tariff.
