SERVICE CLASSIFICATION NO. 1
Residential

APPLICABLE TO USE OF SERVICE FOR:

Single-phase residential purpose usage in an individual residence; in an individual flat or individual apartment in a multiple-family dwelling; for residential purposes in a rooming house where not more than four (4) rooms are available for rent; and for single phase farm service when supplied through the farm residence meter; used exclusively in connection with religious purposes, and including the operation by such corporation or association of a school, not withstanding that secular subjects are taught at such school; for single-phase service exclusively in connection with a community residence as defined in subdivision 28, 28A or 28B of section 1.03 of the Mental Hygiene Law, provided that such residence is operated by a not-for-profit corporation and if supervisory staff is on site on a twenty-four hour per day basis that the residence provides living accommodations for fourteen or fewer residents; and use for any post or hall owned or leased by a not-for-profit organization that is a veterans organization.

CHARACTER OF SERVICE:

Continuous, single-phase alternating current, approximately 60 hertz, 120/240 volts, 3-wire or 120 volts, 2-wire.

APPLICATION TO USE OF SERVICE FOR:

Total requirement customers with monthly kWh ranges of 6,000 or less per month. Customers exceeding 6,000 kWh in any 12 consecutive months shall have a demand meter installed and the account will be moved into Service Classification No. 3 for a period of 12 months.

If consumption is less than 6,000 kWh or less than 20 kW of demand in any billing month for 12 consecutive months, the customer will be returned to Service Classification No. 2.

CHARACTER OF SERVICE:

Continuous, single phase alternating current, approximately 60 hertz, 120/240 volts, or three phase, 208, 240, 480 volts.

All bills are due when rendered. Full payment must be received on or before the date shown on the bill to avoid a late payment charge of 1.5% as provided in Rule VIII of the NYMPA generic tariff.

TERMS:

A customer in this service classification will remain in this service classification for one (1) year after evaluation (July), determination for remaining in this classification shall be a usage of 6,000 kWh or less, and less than 20 kW of demand. The customer will then be transferred to Service Classification No. 3. The customer may terminate service after 48 hours notice in writing to the Village Clerk-Treasurer.

The charges set forth in this service classification shall be subject to a purchased power adjustment as explained in Rule IX of the NYMPA generic tariff.

APPLICABLE TO USE OF SERVICE FOR:

Large commercial or industrial customers whose monthly demand is equal to or exceeds 20 kw in any billing period and or whose energy consumption exceeds 6,000 kWh in any Billing month.

CHARACTER OF SERVICE:

Continuous, single phase alternating current, approximately 60 hertz, 120/240 volts, or three phase, 208, 240, 480, 2400 or 4160 volts.

MONTHLY RATE:

DETERMINATION OF DEMAND:

The maximum demand used for billing shall be taken as the maximum 30-minute integrated demand occurring during the month. The maximum demand shall be measured by 30-minute kW demand meters furnished and installed by the Village of Angelica Electric Department.

MINIMUM CHARGE:

The minimum monthly charge is the demand charge.

SPECIAL PROVISIONS:

Service at 2400 or 4160 volt primary line voltage will be supplied only to consumers who employ and electrician competent to maintain and operate 2400 or 4160 volt equipment.

CHARGES

A. RECONNECTION CHARGE:

When service has been discontinued, either by the municipality as per provided in the NYMPA generic tariff or at the request of the consumer and the same consumer applies for reconnection of service at the same premises within four (4) months, there shall be a reconnection charge payable before service will be reestablished, in the amounts as follows:

\$35.00 during the regular working hours of the Electric Division, Monday through Friday; 6:30am - 3:00pm.

\$50.00 after the regular working hours of the Electric Department, Monday through Friday; and Saturday, Sunday and Holidays.
