## Section 4 – INTRALATA TOLL USAGE AND MILEAGE CHARGES

### 4.1 GENERAL

#### 4.1.1 Description

IntraLATA toll service (also known as Regional toll service) is furnished for communication between telephones in different local calling areas within a particular LATA in accordance with the regulations and schedules of charges specified in this tariff. The toll service charges specified in this section are in payment for all service furnished between the calling and called telephone, except as otherwise provided in this Tariff.

IntraLATA toll calling includes the following types of calls: direct dialed, calling card, collect, 3<sup>rd</sup> number billed, special toll billing, requests to notify of time and charges, person to person calling and other station to station calls.

The charges for Intra-LATA toll set forth in this Section 4 apply when intra-LATA toll calls are separately stated and not included in local and toll bundles, or where a different rate for such calls is not set forth in connection with bundled rate plans.

##### 4.1 GENERAL (cont'd)

##### 4.1.2 Classes of Calls

Service is offered as two classes: station to station calling and operator assisted calling.

- a) Station to Station Service is that service where the person originating the call dials the telephone number desired.
- b) Operator Assisted Service is that service where the person initiating the call requires the assistance of an automated or live operator. Surcharges apply for such calls in addition to base rates.

#### Section 4 – INTRALATA TOLL USAGE AND MILEAGE CHARGES (cont'd)

#### 4.2 TIMING OF CALLS

- 4.2.1 Unless otherwise indicated, all calls are timed in one minute increments and all calls which are fractions of a minute are rounded up to the next whole minute.
- 4.2.2 For station to station calls, call timing begins when a connection is established between the calling telephone and the called telephone station.
- 4.2.3 For operator assisted calls, call timing begins when connection is established between the calling person and the particular person, station or mobile unit specified or an agreed alternate.
- 4.2.4 Call timing ends when the calling station “hangs up,” thereby releasing the network connection. If the called station “hangs up” but the calling station does not, chargeable time ends when the network connection is released either by automatic timing equipment in the telephone network or by the Company operator.

#### 4.3 TIME PERIODS DEFINED

- 4.3.1 All times refer to local time.
- 4.3.2 Day: 8:00 AM – 5:00 PM Monday through Friday
- 4.3.3 Evening: 5:01 PM – 11:00 PM Sunday through Friday
- 4.3.4 Nights: 11:01 PM – 7:59 AM Sunday through Thursday; 11:01 PM to 12:00 (midnight) Friday; 12:01 AM – 11:59 PM Saturday; 12:01 AM – 5:00 PM and 11:01 PM – 11:59PM Sunday

#### 4.4 CALL CHARGES

Rates are based on the duration of the call as measured according to Section 4.2 above. In addition, where live or automated operator assistance is required for call completion or billing, a per call surcharge applies.

Charges for all classes of calls may be to the calling station, to the called station when the called party agrees to accept the charges, to an authorized telephone number which is not the called station or the calling station (3<sup>rd</sup> number billing), or to an authorized calling card.

##### 4.4.1 Usage Charges, per minute

Minimum:

Rates may be reduced selectively and in varying amounts, down to incremental cost, on one day's notice to customers and the Public Service Commission.

4.4.2 Per Call Service Charges

The following surcharges apply to intraLATA toll calls for which live or automated operator assistance is provided for call completion and/or billing.

Customer Dialed Calling Card	\$0.01	\$6.00
Person to Person	\$0.01	\$6.00
3 <sup>rd</sup> Number Billed	\$0.01	\$6.00
All other Operator Assistance	\$0.01	\$6.00
